1. **Decision**

The decision is to submit the proposed Oval scheme to the Local Planning Authority for consideration and decision.

2. **Reasons for the decision**

Following on from extensive stakeholder consultation since November 2022, the proposed designs for The Oval have been continuously developed taking on board feedback. These designs are now sufficiently detailed to seek an outline Planning approval for the entirety of the site, with a detailed application for the first phases.

There have been four series of community consultation beginning in November 2022, with additional sessions in February 2023, July 2023 and November 2023. Members of the Housing Development Working Group and Ward Members were also consulted at each of these stages.

The community consultations have generated over 7000 responses and have helped to shape the final proposals. In the final consultation in November 2023, 62% of all respondents stated that they believe the current proposals meet the aspirations of the community, with only 13% in disagreement with this statement.

3. **Alternative options considered and rejected ²**

The options to carry out further design development ahead of submission and to abort the project were both considered and rejected. This scheme represents one of the key elements of the Housing Development pipeline agreed within the Housing Revenue Account Business Plan and is supported by the community.
