NOTICE IS HEREBY GIVEN that the Stevenage Borough Council, acting as agents for the Hertfordshire County Council in order to maintain and improve the amenity of the area and prevent potentially obstructive parking has made the above Orders under the Road Traffic Regulation Act 1984.

The effects of the Orders would be to introduce permit parking controls to Ansell Court, Baron Court, Cavalier Court, Chapman Road, Cranbourne Court, Fovant Court, Herne Road, Ingleside Drive and Knowle Court with effect from 8.30am to 5.30pm Monday to Saturday. To introduce no waiting at any time restrictions to Baron Court, Chapman Road and Ingleside Drive and prohibit motor vehicles from parking on the verge, footway and crossovers in Ansell Court, Baron Court, Chapman Road, Ingleside Drive and Herne Road. The Orders will come into effect on 2 June 2025.

The parking permits will be available for use in vehicles with a maximum authorised mass of up to 3,500KG and which seat fewer than 12 passengers in addition to the driver and that the charges associated with the scheme will be:
