THE BOROUGH OF STEVENAGE (PERMIT PARKING) ORDER 2018 (AMENDMENT) ORDER 2025

The STEVENAGE BOROUGH COUNCIL (hereinafter referred to as "the Council") pursuant to arrangements made with the County Council of Hertfordshire under Section 19 Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000, in exercise of the powers of the said County Council under Sections 32, 35, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police, hereby makes the following Order:-

- 1. This Order may be cited as "The Borough of Stevenage (Permit Parking) Order 2018 (Amendment) Order 2025" and shall come into operation on 2 June 2025.
- 2. This Order amends the Borough of Stevenage (Permit Parking) Order 2018 (hereinafter referred to as "the Order of 2018" as specified in Articles 3 to 5 of this Order.
- 3. Schedule One of the Order of 2018 shall be amended to include items 12 to 20 inclusive as follows:
