NOTICE IS HEREBY GIVEN that the Stevenage Borough Council, acting as agents for the Hertfordshire County Council and after consultation with the Chief Officer of Police has made the above-named Order under Sections 1, 2, 3, and 32 to 35 of the Road Traffic Regulation Act 1984.

These Orders are made in order to facilitate the passage of traffic on the roads, by preventing hazardous or obstructive parking from taking place and to maintain and improve the amenity of the area by providing loading facilities for goods vehicles. The Orders will come into effect on 1 November 2024.

The general effect of the Orders is to introduce 'no waiting at any time' restrictions as set out in Schedule 1 of this Notice, introduce 'no waiting, no loading or unloading at any time' restrictions as specified in Schedule 2 to this Notice, and introduce a goods vehicles loading bay as set out in Schedules 3 to this Notice.

Full details are provided within the Orders, which together with the plans and a statement of reasons for making the Orders, can be examined during normal opening hours at the Council's offices in Daneshill House. Details can also be viewed on the Council's web site at

Any person wishing to question the validity of these Orders or any provision contained within the Orders on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to that order, may apply to the High Court for this purpose within six weeks of the date on which the orders were made 4 October 2024.

Schedule 1: No waiting at any time – effecting that section of road herein listed and as set out in the Order: Part of Primett Road.

Schedule 2: <u>Prohibition of Waiting, Loading or Unloading – effecting that section of road herein listed and as set out in the Order: Part of Basils Road.</u>

Schedule 3: Goods vehicles loading bay – effecting that section of road herein listed and as set out in the Order: Part of Basils Road.
