NOTICE IS HEREBY GIVEN that the Stevenage Borough Council with the consent of Hertfordshire County Council in order to improve road safety and improve the amenities of the area has made the above Orders under the Road Traffic Regulation Act 1984.

The general effect of the Orders will be to introduce 'no waiting, no loading or unloading at any time' restrictions as specified in Schedule 1, disabled person's vehicles parking places as set out in Schedule 2, goods vehicles loading bays as set out in Schedule 3 and car club parking places as set out in Schedule 4 of this Notice. The Orders will come into force on 20 March 2025.

Full details are provided in the Orders which, together with plans and a statement of reasons for making the Orders, can be examined during normal opening hours at the Council's offices in Daneshill House. Any person wishing to question the validity of these Orders or any provision contained within the Orders on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to those orders, may apply to the High Court for this purpose within six weeks of the date on which the order was made 6 March 2025.

Schedule 1: <u>Prohibition of Waiting, Loading or Unloading – effecting those sections of road herein</u> <u>listed and as set out in the Order:</u> Part of Danestrete.

Schedule 2: <u>Disabled person's vehicles parking places limited to three hours waiting with no return in the next one hour – effecting those sections of road herein listed and as set out in the Order:</u> Part of Danesgate and Part of Danestrete.

Schedule 3: <u>Goods vehicles loading bays – effecting those sections of road herein listed and as set</u> out in the Order: Part of Danesgate and Part of Danestrete.

Schedule 4: <u>Car club parking places – effecting that section of road herein listed and as set out in the</u> <u>Order:</u> Part of Danestrete.
