Also, over the years we have had our vehicles stolen and attempted to be stolen so I installed CCTV cameras and in that parking space we can keep a close watch on our vehicles we agree with you to stop vehicles parking on the corners as this is dangerous but as I have said the space we use and perhaps the other streets this might help other people. The Martins Wood Estate is very difficult for parking as it was built a long time ago. We do hope you will reconsider this for us and others and thank you for your time.

6	-	I live at x Sefton Rd and do agree that there are at times serious issues with people parking on the corners and coupled with excess speeds of some individuals as well as a lack of visibility I have always thought there will be a serious accident at some point. living where I do I get to see what's going on and one big issue is that there are so many large vans parked here that most residents can't park their cars, This coupled with some untaxed cars which never move exacerbate the situation and also there is one individual who owns a lot of people carriers and I wonder whether some sort of resident parking could be an option as all that seems to be happening is people from down near the factory estate park here during the day on top of what I've mentioned previously and all that's happening is the parking issues are being moved further up the road. So, in essence I do think the parking proposals are a very good idea but perhaps some thought could be given to the residents of Sefton Rd and where they can park.
7	-	Thank you for your communication regarding the sensible decision to instigate parking restrictions on Sefton Road. Absolutely no objection here, as the situation has become increasingly dangerous. My only slight concern is that alternative parking isn't being offered and people are unlikely to change their behaviour to the extent of getting rid of a vehicle, leading to the question of where will the cars go? (For the record, our household only has two cars - one on the drive and one in the garage, so we are not contributing to the parking problem and nor will it affect us directly. This is increasingly becoming a problem, both because people are becoming more inconsiderate, and cars/vehicles are getting larger. As you can see from the attached, this marking was very clear back in 2012 when we bought our house but has now faded to virtually nothing

No 10	-	I am a resident of Sefton Road and am very pleased to see that you are proposing to put double yellow lines on the corners of each turning along the road. This has been an issue for a very long time and there have been many near accidents from residents not being able to see either way down the road when pulling out, due to the cars parked on these corners. We are obviously also very concerned that in the event of a fire, an emergency vehicle will have their access blocked. We welcome these changes as soon as possible. Can I also ask if anything can be done to stop the vehicles in the attached photo parking along the road. There are often three of these vans parked up. I do not believe they belong to residents of Sefton Road. Perhaps a sign could be used to advise the drivers that this type of vehicle mush not be parked along the road. I know there are parts of Stevenage where permits are required. Is this something that could be considered for Sefton Road to stop people from other areas parking here? It has become obvious that residents from the flats on Wedgewood Way use Sefton Road to park their cars. I am not sure how much can be done to stop this, but I know it would be greatly appreciated by all residents if the road was not used as an overflow carpark to the flats over the road.
11	-	As a resident I whole heartedly agree with yellow lines being placed around the corners of Sefton Road, it's hazardous and very obstructive.
12	-	I have received a letter re the plans for yellow lines and whilst I agree the lines should be put on the corners, as some people are parking dangerously, I don't agree with elsewhere. Parking is a nightmare as it is round here. Most households having 2-3 cars and a lot of commercial vehicles are parked here also. I have one car and cannot use my drive. So, I must park my car on the road. I have x children and not happy about not being able to park alongside the road near my house.
13		I would like to oppose to the intended yellow line in Sefton Road. Although I completely understand the reasoning behind this, as a resident it's very dangerous with people parking their work vans at the top of the turnings making it very dangerous to see oncoming cars but all this will do is make the situation worse. This all started with the new flats were built on the old Dunlop site, giving each flat one parking space, this led to the residents in parking their cars in Ascot Crescent and one end of Sefton Road. The council then made these yellow lines resulting in all the vehicles moving up to the other end of Sefton Road. If you put yellow lines here, you'll just be moving the problem somewhere else maybe over to Norwich Close! There is no alternative solution given by SBC to relieve the problem. In our street alone we have two lots of flats and 20 houses, one family alone here has x cars another x. We have teenagers still at home with parents or grandparents that are learning to drive so that will be more cars in the street. People must park somewhere so what's your plan to help the residents, they pay their taxes so should be able to park on the road. Have you thought of parking permits in the street or the possibility of using the green opposite the petrol station to use as a car park for the commercial vans or residents.
